Welcome to the 7th EITI Global Conference.

The conference is an opportunity to reconsider the challenge of improving the governance of natural resources in a time of low prices.

After five years chairing the EITI and visiting many countries that are using the EITI to help improve the management of their extractive industries, I conclude that the EITI has achieved a lot in recent years. Transparency has become an expectation not an aspiration. We are beginning to open areas that were previously considered closed – beneficial ownership, commodity trading, state-owned companies.

I am proud of what has been achieved but given that the aim is to improve the management of these resources for the benefit of the people of resource rich countries, much remains to be done. And the process is still too much in its own silo rather than a means to improve transparency in government systems, and is not therefore leading to crucial reform in many countries. The conference is centred around the EITI National Expo. This enables conference attendees to learn directly from those responsible for driving the process in each of the nearly fifty implementing countries.

The conference sessions seek to tackle key issues and draw from experience across the regions. I hope that we will all emerge from this conference with an increased commitment to make the EITI a more useful, relevant and robust tool for reform in these straightened times.

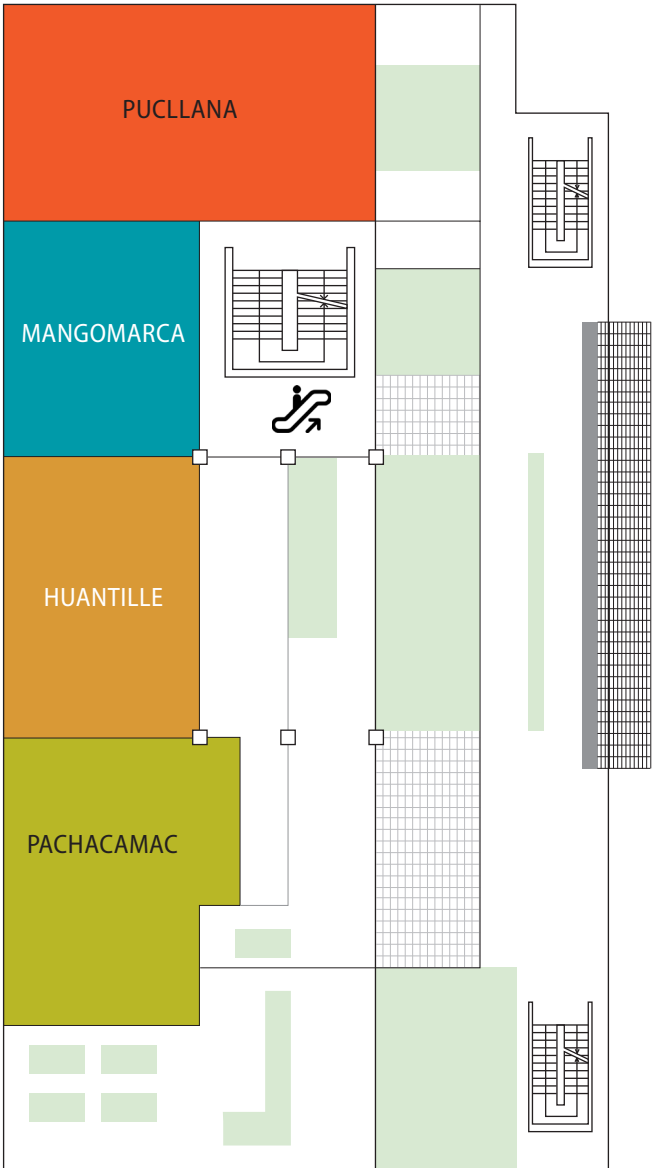

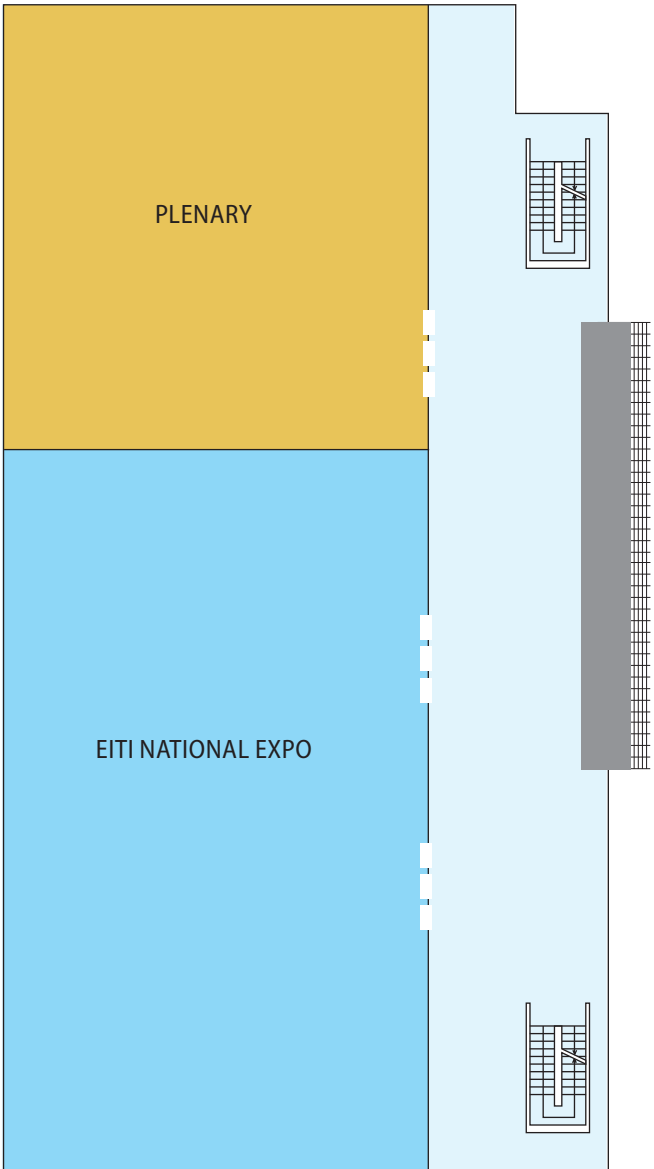

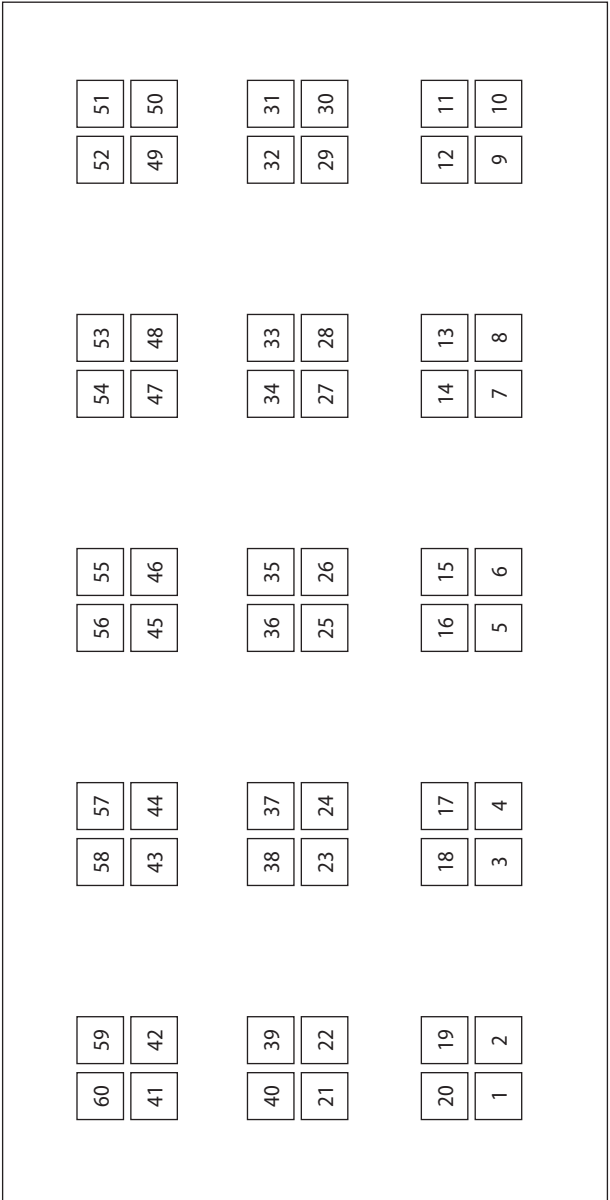
