We are also in the process of including data on oil blocks on the cadastre portal

The Ministry has also a website which we have started populating with data on licensing.

Integration of the Flexicadastre System with the One Stop System (OSSIS) at PACRA

We are in the process of linking up with the Patents And Company Registration Agency to access and extract information from on beneficial ownership. This data will be displayed on our Mining Cadastre Portal in real time.

Integration of Flexicadastre System with the Mineral Value Chain Monitoring System

We are in the process of linking up the flexicadastre system with the Mineral Value Monitoring System in order to capture data on Mineral Production. This will be useful in tracking and enhancing revenue collection in the extractive sector

Integration with the One Stop Shop System(OSSIS) at PACRA

We are in the process of linking up with the Patents And Company Registration Agency (PACRA) to access and extract information on beneficial ownership.

The extraction into our system will occur at time of application. This data will be linked to our online Mining Cadastre Portal in real time.

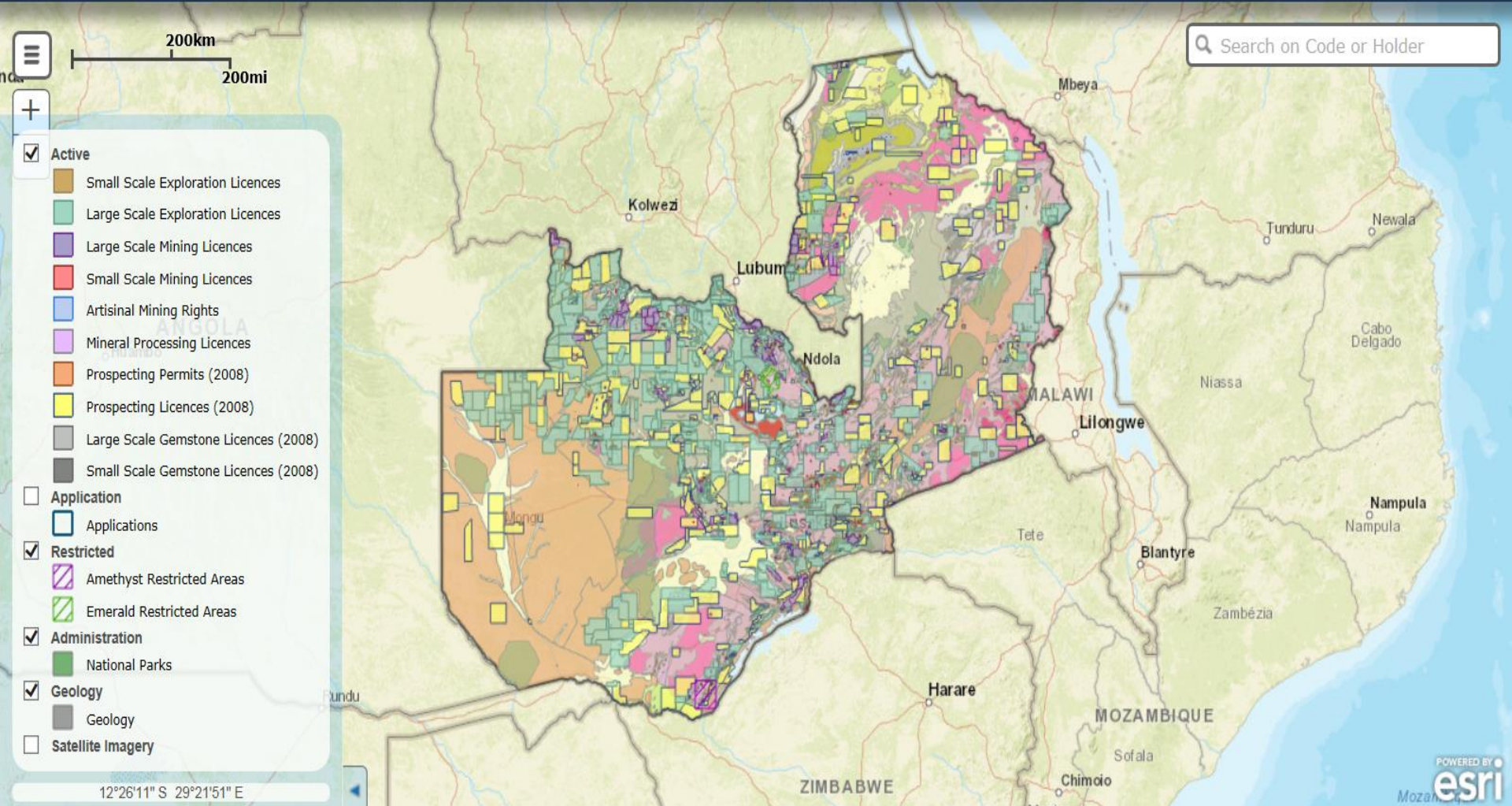


ZAMBIA MINING CADASTRE MAP

Higher Level Strategy of the Government regarding Improved Transparency and Accountability ?7NDP

- **11.4.1 Strategy 1: Strengthen transparency and accountability mechanisms**
- The Government will strengthen structures such as Ward Development Committees, DDCCs, PDCCs and NDCC, to increase avenues for engagement on development issues.
- The Government will also reform Sector Advisory Groups and other advisory institutions to conform them to the integrated development approach of the Plan.
- In addition, the Government will operationalize the provisions of the law which provide for creation of WDCs. The Government will also review the National Anti-Corruption Policy and Act to enhance protection of whistle blowers.
