

Call for views on progress in EITI implementation in Liberia

Liberia joined the EITI in 2007. In May 2017, Liberia's Validation against the 2016 Standard found that Liberia had achieved "meaningful progress" in implementing the EITI Standard. The EITI Board temporarily suspended Liberia following a review in accordance with Requirement 8.62, a suspension that was lifted in March 2020. Liberia's next Validation against the 2019 EITI Standard is scheduled to commence on 1 January 2022.

In accordance with the Validation procedure⁶, the EITI International Secretariat is seeking stakeholder views on Liberia's progress in implementing the EITI Standard between May 2017 and January 2022. Stakeholders are requested to send views to Alex Gordy (Agordy@eiti.org) by 1 January 2022.

The EITI Standard requires that the government, extractive companies and civil society are fully, actively and effectively engaged in EITI implementation. The Secretariat is in particular seeking views on the following questions:

- 1. Are the government, extractive companies and civil society fully, actively and effectively engaged in EITI implementation?
- 2. Are there any obstacles or barriers to the participation of any of these constituencies or their sub-groups in EITI implementation?

The Secretariat is seeking views on the following questions related to industry engagement (Requirement 1.2):

- 3. Are oil, gas and mining companies participating actively in the work of the multistakeholder group and providing or disclosing the data requested by the EITI?
- 4. Is there an enabling environment for company participation in the EITI?

Civil society engagement in the EITI will be assessed in accordance with EITI Protocol: Participation of civil society. Stakeholders are requested to provide input on Liberia's adherence with the protocol.

Any concerns related to potential breaches of the protocol should be accompanied with a description of the related incident, including its timing, actors involved and the link to the EITI process. If available, supporting documentation should be provided. Stakeholders may also

indicate which provision of the civil society protocol they consider the breach(es) to relate to. Responses will be anonymised and be kept confidential.

The Secretariat is seeking views on the following questions related to civil society engagement:

- 5. Are civil society organisations able to engage in public debate related to the EITI process and express opinions about the EITI process without restraint, coercion or reprisal?
- 6. Are civil society representatives able to operate freely in relation to the EITI process?
- 7. Are civil society representatives able to communicate and cooperate with each other regarding the EITI process?
- 8. Are civil society representatives able to be fully, actively and effectively engaged in the design, implementation, monitoring and evaluation of the EITI process?
- 9. Are civil society representatives able to speak freely on transparency and natural resource governance issues, and ensure that the EITI contributes to public debate?

For purposes of the protocol, 'civil society representatives' refer to civil society representatives who are substantively involved in the EITI process, including but not limited to members of the multi-stakeholder group. The 'EITI process' refers to activities related to preparing for EITI sign-up; MSG meetings; CSO constituency side-meetings on EITI, including interactions with MSG representatives; producing EITI Reports; producing materials or conducting analysis on EITI Reports; expressing views related to EITI activities; and expressing views related to natural resource governance.
