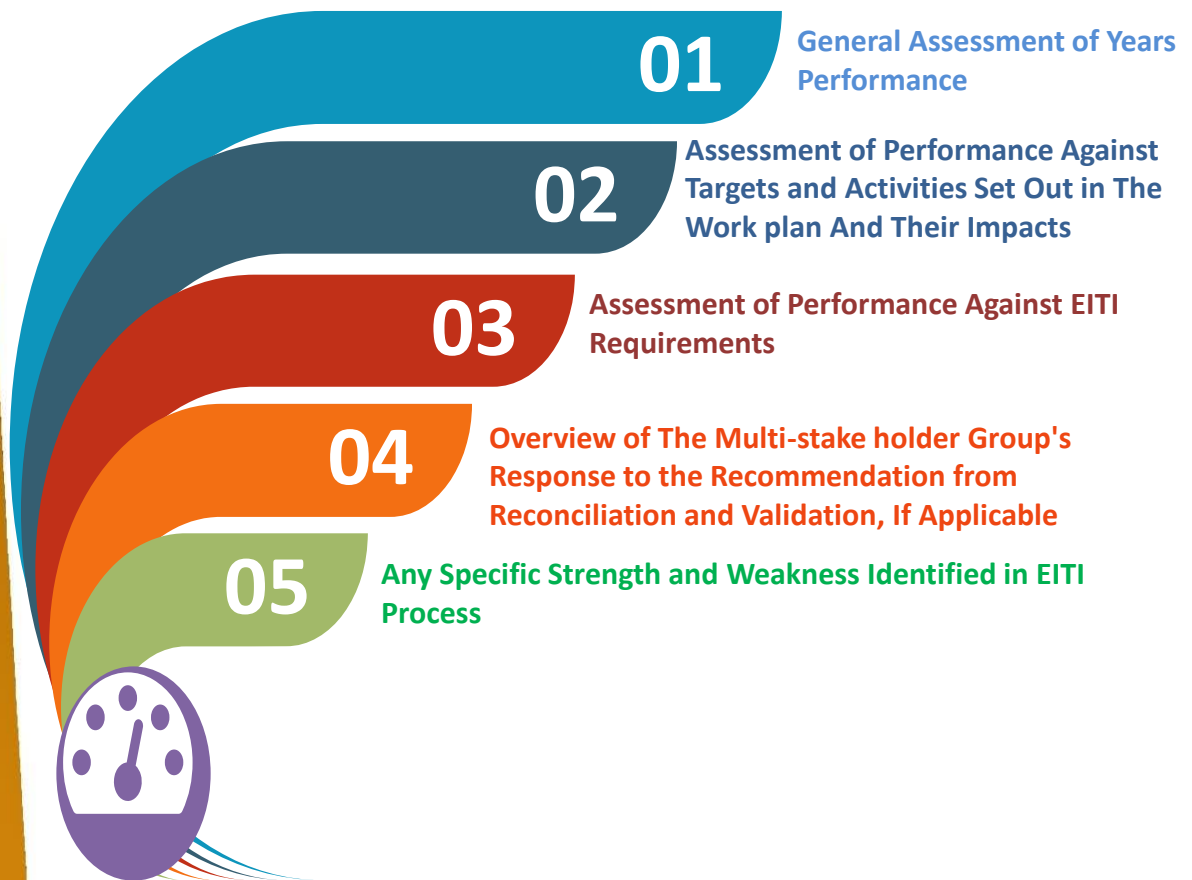

## **1. General Assessment of Years Performance**

On behalf of the Iraqi EITI Stakeholders' Council and National Secretariat, we submit this Annual Progress Report, to elaborate to the Public our efforts of the implementation of the EITI in Iraq throughout the previous year.

The year 2016 has witnessed a tangible progress in the path of IEITI, where the coverage of revenues in both oil and gas sectors has been expanded, based on EITI standard which was formulated to achieve as much transparency as possible in the natural resources. Furthermore, IEITI report included more data and information than what is required by the standard, in order to present to the public the clearest image about the revenues of the natural resources and the mechanisms of its governance.

## **5. Any Specific Strength and Weakness Identified in EITI Process**

### **Obstacle1**

Lack of Resources in the North Area of Iraq: Iraq's low expectations toward the fine tuning of each year's report still the same since we had this great experience of IEITI. This was and still the same obstacle we try to overcome each time we reach, every year we create a plan with no huge success of improving our lack of information's obstacle in the KRG.

### **Treatment**

The independent administrator (KPMG) try to get the data from the ministry of natural resources, where a letter was sent from the independent administrator (KPMG) on 22/8/2016. We had to send a letter to the EITI board on 21/9/2016 to explain that obstacle and the MSG decided to include data from reliable sources.

### **Obstacle2**

The second obstacle of IEITI for the 2015 was repeated according to the mining sector. There is an obvious weakness of issuing creative plans to improve our mining industries sector, this kind of obstacles is difficult since it is not achieved in the right way to be attached according to IEITI need in its reports. There are no external revenues from this sector.

**Treatment**

The ministry of mining sell their production to the private sector to cover their consumption and there are Intangible revenues that made the MSG decide excluded them from the materiality.

- Also, most of the areas of minerals production is located within areas military encounters with the terrorists, which make it hard to implement the investment plans, so the MSG decided to depend on the contextual information of mining.

**Obstacle3**

IOCs lack of communication and attendance. IEITI witnessed numbers of meetings and events, the implementation team is still facing the same obstacle every year which is concerned in the IOCs lack of attendance in IEITI events. This obstacle keeps making the MSG's internal system incomplete, considering that the IOCs are an important element in the complementary distribution of the council of the IEITI.

**Treatment**

EITI should encourage the companies to attend and submit their candidates to the MSG through a representative of these companies in EITI board. IEITI have to hold many of workshops to encourage representative of companies to submit their candidates to attend the MSG meeting periodically. a workshop like this was indeed held in SOC's on December 2016.

**Obstacle4**

The difficulty of ensuring IEITI'S funds through the year of 2015 and 2016.

**Treatment**

- Having strong support from the government through IEITI champion to achieve the financial support.
- IEITI addressed the World Bank and the Iraqi Government (represented by Ministry of Oil) to get the needed fund for supporting EITI implementation.
